Rationale/Summary:

This agenda item relates to the purchase of products, materials, and supplies for 1) infrastructure support and wireless fiber optics, 2) networking and support for data center, cloud, voice and security, and 3) audio visual projects and zoom room installation, services and equipment for projects and related repairs and replacements. Approval of these agreements will allow the university to capitalize on additional discounts and savings. The purpose of this request is to ensure the University can avoid any potential stoppage of work due to running out of purchasing authority and inability to purchase products, materials, supplies, and services timely, and nation-wide issues with supply change delivers.

These suppliers currently are contracted with the Department of Management Services (DMS). Thus, they are considered state-contract vendors/suppliers because they had completed the solicitation process deemed by the state of Florida Board of Governor's Regulation 18.001(1)(c) to offer fixed unit price for goods and services to any State of Florida agency or department, political subdivisions, cooperatives or consortia, or any independent college or university for the procurement of such commodities and contractual services, when it is determined to be cost-effective and in the best interest of the state entities to make purchases.

Data Set Ready, Inc. - state authorized seller of information technology good for telecommunication infrastructure including infrastructure support and wireless fiber optics. These types of materials and supplies are used to replace end of life data cabling and to accommodate new data transport standards at higher speed connectivity to devices and minimize downtown.

Signal House Communications - state authorized seller of audio-visual equipment and accessories including audio visual projects and zoom room installations, services, and equipment. This type of equipment and accessories provide classroom modernization that incorporates learning technologies for higher level of collaboration and interactivity for online and in-person learning.

Presidio Networked Solutions, LLC - state authorized seller of data communication products and services including campus and enterprise network delivery for cybersecurity, wireless internet (WIFI), Multi-Factor Authentication (MFA, Voice over IP (VOIP) and connectivity to life safety, research, and computing systems. These materials and supplies will be addition or replacement for end of life cycle for existing equipment and materials, and leverage advancements in cybersecurity and broadband availability and reliability.



Florida A&M has used DMS's contract unit pricing with Data Set Ready, Inc since 2009; Signal House Communications since 2015; and Presidio Networked Solutions LLC since 2018. The University has exhausted its current purchasing authority for projects that exceed the President's \$1M signature authority. The University is embarking upon several projects including those frequent repairs and replacements in which the University's staffs will be performing much of the work. The staffs want the ability to purchase products, materials, supplies, and/or services from said vendors as needed based on the projects identified in Exhibit A for the fiscal year 2023, which ends June 30, 2023.

Recommendation: The staff seeks the Board of Trustees' approval of the following vendors' agreements substantially in the form set forth on Exhibit B for fiscal year 2023 and for the following specific projects that exceed the President's \$1M signature authority:

- 1. Data Set Ready, Inc.
- 2. Signal House Communications, and
- 3. Presidio Networked Solutions, LLC

- 1. The Education and General budget funds the general instruction, research, and public service operations of the universities. Universities have accumulated ending fund balances for activities such as the implementation and maintenance of Enterprise Resource Program systems, contingency for unfunded enrollment growth, potential budget reductions, anticipated increases in utilities, and prior year encumbrances (recorded, estimated liability at year-end for ordered or received goods or services), and compliance with Section 1011.45 F.S. on maintaining a 7% reserve.
- 2. The Contracts and Grants budget contains activities in support of research, public service, and training. Large fund balances are due to the timing of receipt of Federal contracts or grants.
- 3. Auxiliaries are ancillary support units on each university campus. Some of the major activities include housing, food services, book stores, student health centers, facilities management, and computer support. Ending fund balances includes financial activities such as debt service payments, reserve, repair and replacement reserves for future maintenance costs, construction/renovation of auxiliary facilities, and prior year encumbrances.
- 4. Local funds include the following university activities:
- a. Student Activities Supported primarily by the student activity and service fee and funds operations of the student government, cultural events, organizations, and intramural/club sports.
- b. Financial Aid This activity represents the financial aid amounts for which the university is fiscally responsible. Examples include: student financial aid fee, bright futures, federal grants, college work study, and scholarships. The ending fund balance represents a timing difference between the receipts of funds and disbursement to the students.
- c. Concessions These resources are generated from various vending machines located on the university campuses.
- d. Athletics Revenues are primarily derived from the student athletic fee, ticket sales, and sales of goods. Sufficient fund balances are maintained to provide the necessary support for ongoing athletic
- e. Technology fee Collections are used to enhance instructional technology resources for students and faculty.
- f. Self-Insurance Program These programs are directed by the respective self-insurance councils and the captive insurance companies (These companies underwrite the risks of its owner and the owner's affiliates.). These activities are supported by premiums charged to the insured individuals and entities (primarily medical faculty and institutions).
- g. Board-Approved Fees Student fees proposed by each university and authorized by the Board of Governors to address specific student-based needs not addressed through another service or fee.
- 5. Faculty Practice The Faculty Practice Plan collects and distributes income from faculty billings for patient services provided in conjunction with state university medical school programs.
- 6. Other Receipts/Revenues includes categories such as interest, penalties, refunds, admissions, fines, taxes, etc.
- 7. Other Non-Operating Expenditures includes categories such as refunds, payment of sales taxes, or indirect costs.
