Family Educational Rights and Privacy Act (FERPA)  The 1974 Family Educational Rights and Privacy Act is a federal law (20 U.S.C. 1232g) that protects the privacy of a student's educational record. FERPA applies to all educational institutions receiving funds from the United States Department of Education, from kindergarten through university level. Under FERPA, the Office of Student Conduct and Conflict Resolution may not share the contents of a student's conduct file with anyone other than the student unless the student provides written consent to do so. Exceptions to FERPA include a health or safety emergency or an educational need to know.			
Role of the Advisor  The Florida A&M University Student Code of Conduct affords students involved in the University disciplinary process the right to an advisor of his/her choice. The term advisor refers to any individual who was not directly involved in an incident who is providing advice and/or support for a student during the student conduct process. All students are expected to speak for themselves during any and all student conduct meetings and/or hearings. An advisor may not speak for a student or any other individual in a student conduct meeting and/or hearing without authorization from the chairperson or Student Conduct and Conflict Resolution staff member. Additionally, an advisor may not serve as a witness. A student may consult with the advisor, verbally or in writing, at any time during a conduct meeting and/or hearing. Such consultation must take place in a manner that does not disrupt the proceedings. If the chairperson or Student Conduct and Conflict Resolution staff member determines that an advisor's presence is causing a disruption, the advisor will be given a verbal warning. If the advisor continues to cause a disruption after a verbal warning has been given, the advisor will be asked to leave the hearing or meeting.  Advisor(s)' Information
