U.S. Department of Education Higher Education Emergency Relief Fund 4th Quarter Report Ending December 31, 2021 Emergency Financial Aid Grants to Students

As provided by the U.S. Department of Education (Department), Section 18004(e) of the Coronavirus Aid, Relief, and Economic Security Act and America Recovery Plan Acts (CRRSA AND ARP), Pub. L. No. 116-136, 134 Stat. 281 (March 27, 2020), directs universities in receipt of federal funding under Section 18004 of the CRRSA AND ARP to submit a report to the Secretary of Education describing the use of funds distributed from the Higher Education Emergency Relief Fund ("HEERF"). Section 18004(c) of the CRRSA AND ARP requires institutions to use no less than 50 percent of the funds received from Section 18004(a)(1) of the CRRSA AND ARP to provide Emergency Financial Aid Grants to students for expenses related to the disruption of campus operations due to coronavirus (including eligible expenses under a student's cost of attendance such as food, housing, course materials, technology, health care, and child care).

Reporting for the seven enumerated criteria provided on May 6, 2020, by the Office of Postsecondary Education is as follows:

- Florida A&M University signed the Certification and Agreement on April 9, 2020, and returned to the U.S. Department of Education on April 10, 2020 for Emergency Financial Aid Grants to students for expenses related to the disruption of campus operations due to coronavirus. The University has received two additional awards all totaling \$31,323,840.
- Florida A&M University has received a total of **\$31,323,840 since April 20, 2020**, from the Department pursuant to the Certification and Agreement for Emergency Financial Aid Grants to students for disbursement in accordance with Section 18004(a)(1) of the CRRSA AND ARP.
- The total amount of Emergency Financial Aid Grants distributed to students under Section 18004(a)(1) of the CRRSA AND ARP as of **December 31, 2021**, is approximately **\$28,456,228**.
- It is estimated that 8,998 students at Florida A&M University are eligible to participate in programs under Section 484 in Title IV of the Higher Education Act of 1965 and thus eligible to receive Emergency Financial Aid Grants to students under Section 18004(a)(1) of the CRRSA AND ARP.
- To date, over 8,998 students have received an Emergency Financial Aid Grant as provided under Section 18004(a)(1) of the CRRSA AND ARP.
- The University implemented a tier awarding methodology to determine which students receive Emergency Financial Aid Grants and how much they would receive under Section 18004(a)(1) of the CRRSA AND ARP. The basis of this determination is in accordance with the U.S. Department of Education recommendation of providing emergency grants to students with the greatest financial need. The Pell eligible students who may be most vulnerable to the COVID-19 pandemic were the priority. The University will then focus on our non-Pell eligible, Graduate and Professional students with an Expected Family Contribution (EFC) up to \$15,000.
- Guidance was provided to students via the university COVID-19 Coronavirus Alerts webpage, the Office of Financial Aid webpage, and the University Virtual Student Town Hall meeting. In addition, an email was sent via FAMU Info with a link to the CRRSA AND ARP Emergency Grant Spending Plan.

As provided by the Office of Postsecondary Education on May 6, 2020, Institutions that accurately report the information listed above will meet the initial reporting requirements.

Awarding Methodology

CRRSA AND ARP III and HBCU/HBGI Funding Methodology

FAMU has allocated 50M from the following funding sources to assist students with college-related expenses aligned with our cost of attendance determinations.

Each student enrolled in a degree-seeking program except students designated as “special” or non-degree seeking will receive 5000k, payable in two equal installments of \$2500 for fall and spring semesters. Please see the following proration chart of Awards.

| Enrollment by Credit Hour | Fall Award | Spring Award | Total |
|---|-------------------|---------------------|--------------|
| Fulltime (12 or more UG/9 or more GR) | \$2,500 | \$2,500 | \$5,000 |
| 3/4 time (9-11 UG/7-8 GR) | \$1,875 | \$1,875 | \$3,750 |
| Half-time (6-8 UG/5-7 GR) | \$1,250 | \$1,250 | \$2,500 |
| Less than half-time (less than 6 UG/less than 5 GR) | \$625 | \$625 | \$1,250 |

After the initial awarding of students, the university reserves the right to review students’ overall awards to determine eligibility for additional funding with priority going to students with EFC’s less than \$5,000 for the 2021/22 award cycle.
