i. Point system Voting

- Small changes on the wording that create specificity
- Update: automatic elimination of candidate in the event that they vote on someone's phone for themselves
- President May: How do you plan to authenticate reports of voting fraud? A: attempting to make voting an in person process as oversights are difficult. Also relying on the oversight of RA's who have a closer viewpoint on candidates.
